1. Security concepts can be included in syllabus content of 19CIE401 - Advanced Java Programming
2. 19MAT501- Discrete Mathematics subject is replaced with 19MAT501- Mathematical Foundations for Cyber Security in the Fifth Semester in order to incorporate Cyber Security concepts in Mathematics.
3. 19CIT502 - Physical and System Security can be changed from Theory Course to Embedded Theory Course and Subject Code also be changed as 19CIE501.
4. The title of the Subject 19CIT501 - Theory of Computation and Compiler Design be changed to 19CIT501 - Compiler Design and the fundamentals of Theory of Computation also included in the content of the syllabus.

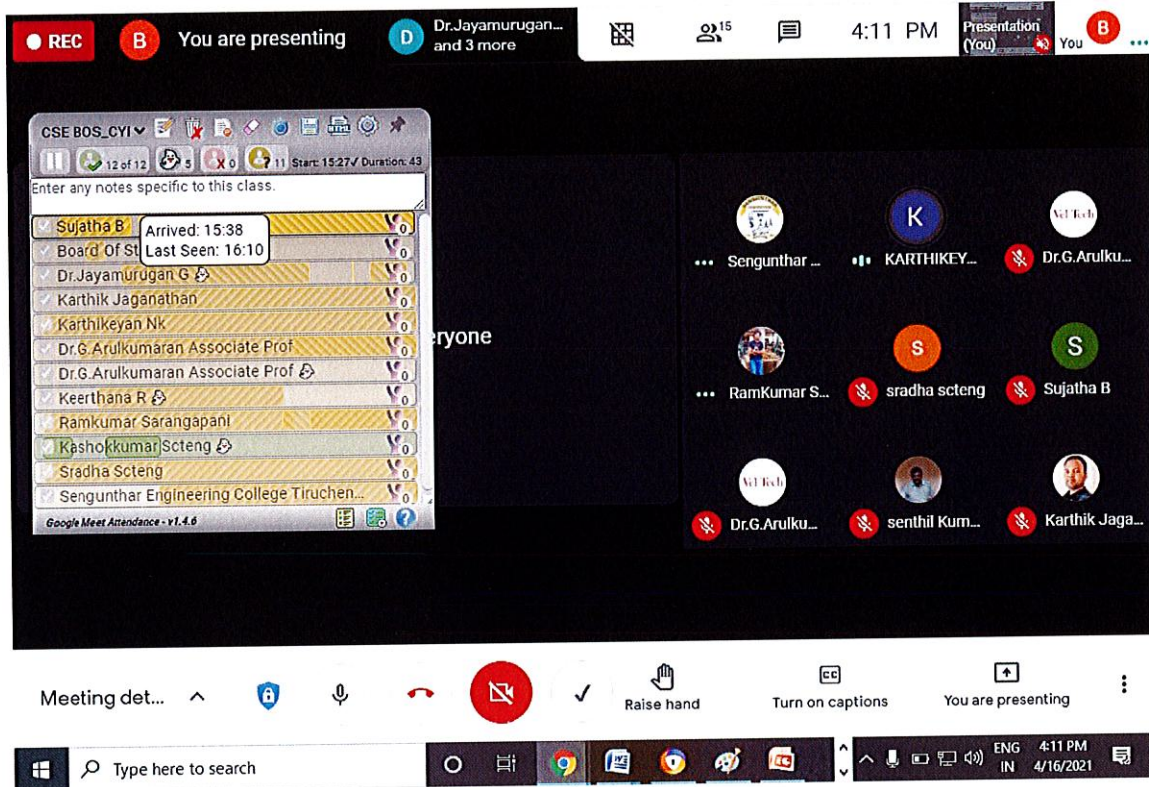
